COLLECTION OVERVIEW

As civil rights historiography moves deeper into its second phase, the study of local and community organizations becomes more important. The papers of Vernon Z. Crawford and the records of the Blacksher, Menefee, and Stein Law Firm from the holdings of the University of South Alabama Archives comprise an extensive collection of civil rights material and represent a significant contribution to civil rights scholarship. Scholars are now focusing on the local dimensions of the post-1965 period, when strategies shifted and civil rights organizations turned to a variety of issues that differed from the targets of the 1950s and early 1960s. While scholars have focused on activities in Birmingham and Montgomery, Alabama, this collection opens a wider study into the activities of another Alabama city, one with a unique ethnic mix, as well as a unionized work force that rivaled that of Birmingham.

The Legal Battle for Civil Rights in Alabama is drawn from the papers of Vernon Z. Crawford and the Blacksher, Menefee, and Stein Collection. It features files on lawsuits relating to topics like school desegregation, discriminatory juror selection, and minority vote dilution. Materials filmed include legal documentation, complaints, petitions, requests, depositions, handwritten notes, correspondence, exhibits (maps, plans of school buildings, population diagrams), news clippings, and surveys relating to major legal cases.

This microform edition will be of interest to researchers in political science, history, law, and other fields as an opportunity to examine essential primary documents surrounding several major civil rights cases tried in Alabama during the past four decades.

INTRODUCTION TO THE COLLECTION

The papers of Vernon Z. Crawford and the Blacksher, Menefee, and Stein Collection comprise an extensive collection of material documenting the legal battle for civil rights in Alabama in the latter part of the twentieth-century. The microform edition of *The Legal Battle for Civil Rights in Alabama*, assembled here by Primary Source Media, provides insight into key legal battles regarding school desegregation, discriminatory juror selection, and minority vote dilution. Crawford and his partners confronted Jim Crow in the courtroom during the height of the civil rights movement; their victories had national ramifications that are still felt today.

Vernon Zionchek Crawford was born in Mobile, Alabama in 1919. At that time Mobile remained an economically depressed city, especially for the African American population. African Americans in Mobile were as harshly segregated as in other southern cities, particularly in education and employment. Crawford joined the Merchant Marine shortly before World War II. Following the war, he chose to leave the shipping industry and enrolled at Alabama State University. In 1951, after his graduation, Crawford decided to pursue a career in law from Brooklyn Law School in New York.

While Crawford worked toward a law degree in New York, the racial climate in the south began to deteriorate. In 1954, the United States Supreme Court outlawed segregation in public schools with its decision in *Brown v. Board of Education*. The *Brown* decision precipitated a parallel resurgence in African American activism and white resistance. Reactionary forces began forming Citizens' Councils and southern political leaders sought ways to circumvent the *Brown* decision and prevent further gains in civil rights. In June of 1956, just one month after Crawford was admitted to the state bar, Alabama Attorney General John Patterson secured an injunction against the NAACP for its failure to register as an out-of-state organization. The ruling destroyed the NAACP's ability to operate legally in the state until 1964. Crawford returned to Mobile and opened a practice on Davis Avenue, in the center of Mobile's African American community. Over the next thirty years, his firm would participate in some of the most far-reaching legal cases of the civil rights era.

In Mobile, civil rights activists reorganized under the banner of the Non-Partisan Voters' League. One of the League's most prominent members was local postman John L. LeFlore. He cultivated a working relationship with Crawford, who became counsel for the League. One of their earliest legal efforts was the *Willie Seals* case. Seals was convicted of rape by an all-white jury in 1958 and sentenced to death. The Non-Partisan Voters' League retained Crawford for the appeal. He argued that the systematic exclusion of African Americans from the jury rolls infringed upon Seals' constitutional rights and applied for a writ of error. The Alabama Supreme Court summarily rejected Crawford's argument, but the U.S. Fifth Circuit Court of Appeals reversed the decision in 1963 and granted one of the first writs of error in Alabama history. The *Seals* decision had national ramifications and served as a precedent for the integration of juries throughout the south. Seals was finally released in 1970 after a twelve-year incarceration.

Shortly after the *Seals* decision, Crawford and the League intervened in another local case. Nathaniel Taylor was charged with the brutal murder of Lillian Kohorn in 1964. Taylor was arrested on the day of Kohorn's murder for seeking work without a permit and confessed to killing the woman after a thirty-eight hour interrogation. Crawford secured an acquittal after a psychologist testified that Taylor's mental disability prevented him from giving a voluntary confession. The prosecution had no physical evidence that linked Taylor to the crime and he was released in July 1965. The *Taylor* case, along with the *Seals* case, established a strong partnership between Crawford's firm and the Non-Partisan Voters' League.

In late November 1962, John LeFlore presented a petition for the desegregation of Mobile schools, signed by the parents of twenty-seven African American students, to the all-white school board. At the time, Mobile's school system was the largest in Alabama with eighty-nine schools and 72,000 students, 40% of whom were African American. When the school board failed to act on the petition, NAACP counsel Constance Baker Motley announced that the Legal Defense Fund would support further legal action. Crawford became a cooperating attorney for the NAACP's Legal Defense Fund and shifted his focus to civil rights litigation. On March 27, 1963, Vernon Crawford filed suit against the Mobile County School Board on behalf of Birdie Mae Davis, Henry Hobdy, and twenty other African American students. Within two weeks, legal battles in Mobile were overshadowed by the beginning of Martin Luther King Jr.'s campaign in Birmingham. Over the next four months, protests and violence in Alabama's "Magic City" dominated the national attention.

In June 1963, Judge Daniel Thomas ordered the school board to submit a desegregation plan for the 1964-1965 school year. The Board chose a "backwards stair step" plan that would begin with the twelfth grade and move down over the next several years. The plan would initially desegregate the three high schools. Immediately following the decision, reactionary whites in the Mobile area formed several organizations to oppose integration. Their protests would shatter Mobile's reputation as a city of racial moderation.

White Mobilians were not the only ones concerned with the desegregation plan. Democratic Alabama Governor George C. Wallace ordered state police to several Alabama cities and successfully prevented desegregation of Mobile schools on September 9, 1963. His success was short-lived as Birdie Mae Davis and Henry Hobdy, two African American students, enrolled in classes the following day. The next five days witnessed confrontations at schools and a growing resistance to integration. School desegregation would remain a major factor in Mobile politics for the next decade. The effects were immediately visible. In 1964, Mobile voted for Republican candidates for the first time since Reconstruction.

The *Birdie Mae Davis* case can be divided into two distinct phases. From 1964 to 1970, *Birdie Mae Davis* involved "freedom of choice" and zoning laws. After numerous reversals by Judge Daniel Thomas and the Fifth Circuit, the case was added as a companion case to *Swann v. Charlotte-Mecklenburg*, which was heard before the Supreme Court in October 1970. In that case, the Supreme Court ruled that busing could be used to achieve integration, which resulted in another shift in tactics for *Birdie Mae Davis*. After 1970, the *Davis* case took on a life of its own as LeFlore and other African American leaders were increasingly occupied with school desegregation, leaving Crawford and his partners to negotiate with

school board attorneys. The case officially ended in May of 1997, with the dubious distinction of being one of the longest-running school desegregation cases in America.

School desegregation, and the specter of busing in particular, dramatically altered the political climate in Mobile. The rise of white resistance coincided with the emergence of a new civil rights organization in Mobile, The Neighborhood Organized Workers. Organized in 1966, NOW was transformed in 1968 by Noble Beasley, a native Mississippian with a checkered past, who became president of the group shortly before the assassination of Martin Luther King Jr. in April. Leaders of NOW applied for a permit to hold a march in honor of the slain leader. When their request was refused, Beasley sent marchers into the street where they were joined by large numbers of sympathizers. The King march inaugurated a period of confrontation between the organization and city officials. In 1969, NOW demonstrated outside the Junior Miss Pageant in Mobile before a national audience. During the incident mass arrests took place; John LeFlore and Vernon Crawford, who were observing the protests, were incarcerated. Later that year, NOW leaders announced a boycott of the municipal elections. The boycott was opposed by the Non-Partisan Voters' League because it endangered the League's practice of endorsing moderate white candidates through the "pink sheet" campaign. Despite the League's opposition, the boycott resulted in a recordlow turnout in the city's African American wards and contributed to the defeat of Joseph Langan, a white moderate and long-time supporter of LeFlore and the politics of gradualism.

The emergence of NOW presented John LeFlore and the League with a tactical dilemma. With its older strategy effectively repudiated, the League shifted its focus from electing candidates to changing the structure of government itself. Since 1911, Mobile had elected city commissioners through at-large elections. The practice, which also applied to school board elections, effectively precluded the election of an African American candidate, leaving African Americans to seek influence as "swing voters" in contests between white candidates.

By 1973, plans were being made to challenge Mobile's form of government. Earlier efforts to convince voters to approve a mayor-council government were soundly defeated. The defeat proved that the only effective way to achieve a reversal of sixty years of discrimination would be through a class-action lawsuit. While plans for the suit were forming, Crawford's firm steadily grew. James Blacksher, a white graduate from the University of Alabama, joined the Crawford Firm in 1971. He was joined by two other white attorneys, Larry Menefee and Greg Stein who would soon take on most of Crawford's civil rights work.

In July 1975, twelve African American Mobilians filed suit charging that Mobile's at-large form of government diluted minority voting rights in violation of the 1965 Voting Rights Act. The principle plaintiff in the case was Wiley Bolden; a World War I veteran who fought in segregated American units in France and Germany and had helped John LeFlore organize the Mobile NAACP in 1926. On January 19, 1976, *Bolden v. City of Mobile* was certified as a class action lawsuit. Judge Virgil Pittman opened the case that July. Pittman agreed to a tour of Mobile's African American wards to see first hand the salutary neglect perpetuated by the at-large form of government. During these hearings, the Crawford Firm initiated a similar suit, *Brown v. Moore*, charging that the at-large election of school board members

was unconstitutional. *Brown* and *Bolden* became inextricably linked, using the same attorneys, witnesses and evidence. Judge Pittman ruled in both cases during the 1976 term. He found for the plaintiffs and agreed that the at-large elections diluted minority voting strength and ordered a mayor-council government be implemented by 1977. These plans were halted however when the City of Mobile appealed the ruling to the U.S. Supreme Court. The defendants in the *Brown* case acquiesced to Pittman's ruling and divided the school board into five districts, resulting in the election of two African American school board members in 1978. The men were met with hostility by other board members. By 1977, actions in *Bolden*, *Brown*, and *Birdie Mae Davis* had evolved into a complex web of litigation. James Blacksher, Larry Menefee, and Greg Stein, the three white lawyers in the Crawford Firm, left to form their own practice to deal specifically with the civil rights cases that Vernon Crawford and the League had initiated over the last fifteen years.

The *Bolden* case resulted in similar suits during the late 1970s in Hattiesburg, Mississippi, Little Rock, Arkansas, and Jackson, Tennessee. The cases suffered a significant setback on April 22, 1980 when the Supreme Court ruled in the *Bolden* case. In a 6-3 decision, the court stated that in order to establish a violation of the Voting Rights Act, the plaintiffs had to show evidence of intent to discriminate. Until such evidence could be produced, the *Bolden* case remained on hold. In early May 1980, Mobile School Board president Dan Alexander dismissed both African American board members, stating that the precedent that secured their election was no longer valid. Four years passed before they were allowed to return.

Between the Supreme Court ruling and the second phase of the *Bolden* case, race relations in Mobile continued to deteriorate. Two months before the trial resumed, a nineteen-year old named Michael Donald was kidnapped by two Klansmen and murdered. The Klansmen took Donald's body and hung it from a tree in downtown Mobile, in retaliation for the acquittal of an African American man for killing a white police officer. The Donald lynching outraged Mobile's African American community. The incident drew national attention and Jesse Jackson came to Mobile to lead protests. During a speech, Jackson noted that the real crime was the "political lynching" that had occurred in Mobile since 1911 by the discriminatory form of government. A few months after the murder, Mobile reelected all three incumbent commissioners in the face of a final ruling in the *Bolden* case.

During the second trial, new evidence emerged. In 1909, a United States Congressman from Mobile's district had sent an open letter to the *Mobile Register* in support of the proposed atlarge commission. The letter ended with an admonition that the at-large government could effectively control and exclude the African American vote. Similar letters were uncovered and proved sufficient evidence for Judge Pittman, who ruled in favor of the plaintiffs on April 15, 1982. City officials chose not to appeal the ruling and agreed to a settlement which included a new form of government. A referendum was held in April 1985 where Mobile voters approved the mayor-council form of government. In July, the first African American representatives in the city since Reconstruction and the first female representatives in the city's history were elected. In 2004, Sam Jones became Mobile's first African American mayor.

The *Bolden* case had ramifications far beyond Mobile. The Supreme Courts ruling against the plaintiffs in 1980 reenergized civil rights activists in Congress to revise the Voting Rights Act of 1965. When the measure was reauthorized in 1982, James Blacksher testified before Congress. Congress amended Section 2 of the Voting Rights Act to state that if a voting practice has the effect, not necessarily the intent, of discrimination, then it is invalid. In Mobile, Wiley Bolden was heralded as a courageous lifetime advocate of civil rights. He was present at the first commission meeting in 1986 and received a standing ovation from the commissioners. The ninety-three year old activist was a finalist for the NAACP Spingarn Award for African American achievement. He died in February 1987.

After the conclusion of the Bolden case, Vernon Crawford retired from his legal practice of thirty years and, at the insistence of several prominent African American business leaders, ran for a place on the new city council in 1985. Crawford suffered a stroke during the campaign and died in January 1986. He is remembered as a pioneer litigator in civil rights cases.

In 1989, the University of South Alabama Archives received the Blacksher, Menefee, and Stein Collection, including materials on Birdie Mae Davis, Brown v Moore, and Bolden v City of Mobile. In 2005, Vernon Crawford's widow donated his legal and personal papers, which comprise one of the few collections devoted primarily to an African American lawyer in the south. The microform edition assembled here by Primary Source Media from the holdings of the University of South Alabama Archives represents a significant contribution to the history of the legal battle for civil rights in the south. As the scholarship of the civil rights movement continues to evolve, the study of community organizations and activities become more important for understanding the struggle for racial change. Scholars of school desegregation and political history will find much new material in the collection. The three major cases represented here provide insight into how local issues affected national policy. This microform edition further compliments *Civil Rights and Social Activism in Alabama*, which includes the papers of John LeFlore and the Non-Partisan Voters' League, adding to the rich and uncharted history of the Gulf Coast's role in the civil rights movement and the legal battle for civil rights in Alabama.

Organization and Format

The Legal Battle for Civil Rights in Alabama is comprised of two parts:

Part 1: Vernon Z. Crawford Records, 1958-1978: Civil Rights Cases (6 reels) consists of Series III and Series IV from the original collection at the University of South Alabama Archives.

Part 2: Selections from the Blacksher, Menefee and Stein Records. (37 reels) includes the following cases from the BMS Collection: Bolden v. City of Mobile; Brown v. Moore; and Birdie Mae Davis et al v. Board of School Commissioners of Mobile County.

Materials are arranged in the reels based on the organization developed by the University of South Alabama Archives. This guide lists materials on the folder level in the order in which they appear on the reels. Consult the *Display Comments* field for more information regarding what items or folders were not filmed.

Selection Process

The selection of materials for the microform edition of *The Legal Battle for Civil Rights in Alabama* was based on the following:

Privacy

Some materials could not be microfilmed for reasons of confidentiality. In the interest of protecting the privacy of individuals, a concerted effort was made to exclude records that contained people's home addresses, phone numbers, Social Security numbers, or personal financial information. Resumes were not filmed.

Rarity

Some printed materials, such as commonly held government reports or court documents, were excluded because they can be found in many libraries. Examples of materials not filmed include Supreme Court and Court of Appeals documents, as well as entire folders of newspaper clippings.

Notice of Unfilmed Materials

Materials excluded from within a folder are noted in the *Display Comments* field for the file in which they are housed. Files excluded in their entirety are listed in this collection guide and denoted with a "not filmed". All unfilmed materials are available to researchers who use the collection on site at the University of South Alabama Archives.
