## Introduction

This FBI file provides an excellent case study of the tracking of a hate group by the federal government. A group of right-wing extremists, the Posse Comitatus, was formed in Oregon in the early 1970s. Established as a group of citizens "voluntarily acting in the name of the local sheriff to enforce the law," it targeted Jews, African Americans, and government officials above the rank of sheriff as objects of its hatred. The Posse held the federal government in contempt as illegitimate, recognized lawful authority only on the county level, and advocated tax rebellion. The file covers the period 1973-1977 and 1980-1996. It contains copies of hate literature, details of a bombing, and notes from several income tax evasion trials.

The documents reproduced here were drawn from the Washington files of the FBI and have been released under the Freedom of Information Act; certain documents or portion of documents have been deleted by the FBI pursuant to provisions of that legislation. The material has been filmed in the exact order and condition in which it was released, and every effort has been made to publish the most legible copies available.

This file is in approximate chronological order, and the FBI did not index documents. The Roll Notes is not a complete inventory of the file; however, it gives an indication of the types of materials or specific documents that may be particularly worthwhile for research.
