Introduction

The political career of "Kingfish" Huey Long was marked by corruption, obsession with and abuse of power, and a Populist rhetoric calling for redistribution of wealth. His maverick politics, while an outrage to his political opponents, nevertheless gained him enough popularity to catapult him to both the Louisiana governor's post as well as a U.S. Senate seat. In the late 1920s and early 1930s, Long was in control of virtually every aspect of the Louisiana political system, probably wielding more power than any other governor in American history.

As senator, Long introduced a program for redistribution of wealth, but it was rejected by the Senate. He was often at odds with the leaders of his Democratic Party and even announced his intention to an against President Franklin D. Roosevelt in the 1936 presidential election. Long was assassinated in October 1935, one month after his announcement, while visiting Baton Rouge to attend a special convening of his legislature.

This FBI file on Huey Long details the organization's investigation of Long mainly during the 1920s. Many of the reports of his activities refer to voting fraud. Also of interest are the large amount of memos produced by FBI Director J. Edgar Hoover. This collection is an important resource for studies in political science and American history.

The documents reproduced here were drawn from the Washington files of the FBI and have been released under the Freedom of Information Act. The FBI, pursuant to provision of that legislation, has deleted certain documents or portion of documents. The material has been filmed in the exact order and condition in which it was released, and every effort has been made to publish the most legible copies available. This file is in approximate chronological order, with newspapers as a subsection. The FBI did not index documents. The Roll Notes is not a complete inventory of the file; however, it gives an indication of the types of material or specific documents that may be particularly worthwhile for research.
