Introduction

Founded in 1909, the National Association for the Advancement of Colored People (NAACP) became the leading organization advocating equal rights for minorities, a status it still claims. The Federal Bureau of Investigation (FBI) file on the NAACP, officially entitled "Communist Infiltration of the National Association for the Advancement of Colored People," spans the years from 1941 to 1957, a period in which many significant events of the civil rights movement took place. The FBI kept close tabs on the movement in the 1940s and 1950s despite the lack of federal civil rights legislation at that time. Alleged Communist infiltration of the NAACP, which was involved in protesting civil rights abuses, and Communist party exploitation of these abuses in order to gain political power were enough to keep the FBI interested. As a result, nearly all of the significant events of the movement are well documented. These events and investigations include: the Scottsboro trial (1942), possible enemy agitation among blacks during World War II, the Detroit riots (1943), postwar lynchings in the South, various instances of police brutality, voting code violations, discrimination against black soldiers in World War II and Korea, the Birmingham bombings (1951), the Oakland Fire Department discrimination case (1951), reaction to the Supreme Court decision on Brown v. the Board of Education (1954), controversy surrounding the FBI's handling of southern investigations in the 1950s (most notably the 1955 Emmett Till case), the National Conference on Civil Rights (1956), the Alabama busing controversies (1955, 1956), and full reports on every NAACP Annual Conference from 1942 to 1956.

The FBI's concerns were not entirely unfounded. Some prominent early black civil rights leaders, such as NAACP founder W. E. B. DuBois and entertainer Paul Robeson, were leftists; and although the national leadership of the NAACP made constant anti-Communist statements, the FBI was convinced that party members were trying to take over branch organizations and wrest power from the local officers. The party also tried to use civil rights abuses to its own advantage, and this conflict made the NAACP an easy

target for allegations of Communist ties and sympathies. Accordingly, the FBI compiled detailed information on every known branch of the NAACP through the Bureau's field offices. Although instances of Communist infiltration were rare, the lists of branch officers and activities are unusual and useful research tools for historians of the civil rights movement.

Another interesting facet of this file is the correspondence between NAACP Executive Secretary Walter White and FBI Director J. Edgar Hoover, which was surprisingly cordial. NAACP-produced material, including newspaper advertisements, newsletters, membership drive literature, copies of the *Crisis* (the NAACP's official publication), annual reports, and news releases also are contained within the file, as well as some prosegregation literature.

The documents reproduced here were drawn from the Washington files of the FBI and have been released under the Freedom of Information Act; certain documents or portions of documents have been deleted by the FBI pursuant to provisions of that legislation. The material has been filmed in the exact order and condition in which it was released, and every effort has been made to publish the most legible copies available.

The file is in chronological order, and the FBI did not index documents. The Roll Notes is not a complete inventory of the file; however, it gives an indication of the types of material or specific documents that may be particularly worthwhile for research.
