Introduction

The "Society for Propagation of the Gospel in New England" was chartered in 1649 for the purpose of converting the New England Indians. In 1661/62 it was rechartered and named the "Company for Propagation of the Gospel in New England and the parts adjacent in America." The Company sponsored missionaries in America until the Revolutionary War at which time its missionary activities were turned to Canada. In 1961 it was still functioning under the name of the "New England Company."

The Company's function was that of a corporation. The revenues from its investments, chiefly in property, were sent to Commissioners in New England who in turn paid the missionaries or dispersed the funds as directed by the Company. The "Commissioners for Indian Affairs," as they were designated, were appointed by the members of the Company, and were usually Boston merchants, or New England officials.

The Letter Book

The majority of correspondents in the Letter Book, 1688-1761, are the Company's governors, secretaries or clerks, and treasurers who are writing to the Commissioners in America. Letters discuss affairs of the Company, requests and directives to the Commissioners, and financial matters. The Company's affairs concern the education of the Indians, with references to Harvard College and other schools supported by the Company, the providing of religious texts in translation, and the settlement of the Indians on their own separate lands. Financial matters concern the dispersal of funds sent the Commissioners, and attempts to collect money from the Company's investments in England. In addition, the Letter Book contains copies of various charters dating from 1662, financial receipts, deeds, indentures, and other legal papers.

The Letter Book is 322 numbered pages of laid paper with writing on 321. It is 31.5 centimeters, bound in vellum with a blind tooled design on both front and back covers.

A book plate on the interior of the front cover states that the volume was sold by Richard Wootton, Stationer, White Hart, in Kingstreet by the Guildhall. In all probability the volume was purchased in the first quarter of the Eighteenth Century and the earlier letters copied into it at that time.

The arrangement of the items is generally chronological by year; however, within the year letters appear to have been copied at random. Documents, especially the charters, are not in chronological order.

The microfilm of the Letter Book was filmed at a reduction of 12:1, two pages to a frame and occupies approximately 20 feet of microfilm.

Provenance

The Letter Book was acquired by the University of Virginia Library in 1938 as part of the Mather Collection of the Tracy W. McGregor Library. Mr. McGregor had acquired the Mather Collection from William Gwinn Mather in 1935. This collection consists of manuscripts of various members of the Mather family,

especially Cotton and Increase, and printed materials pertaining to the Mathers and the Puritan Movement in New England. William Gwinn Mather had purchased the Letter Book from the dealer Henry Stevens, Son & Stiles, London, in January 1925. The whereabouts of the volume before 1925 has not been determined.

The Guildhall Library in London possesses the Company's Letter Book, 1762-72, and other archives of the New England Company which were transferred to their custody in 1953. A search by the Guildhall Library at that time revealed no other letter books.

The Index

The index cites only personal names—correspondents, recipients, signators, witnesses, and names on financial receipts. Names appearing within the text were not included.

Names were keyed to the pagination which appears either on the outer corners or on the middle of the pages. Paging was chosen as the keying device because frequently letters of the same date do not appear in order.

Paging numbers give the full extent of the item; ie. 123, 123-25, 125, indicates that there are three items, the second occupying page 124 and part of pages 123 and 125. Two or more items are also shown, ie. 120 (3 items). This method was chosen to indicate the number of items relating to each name.

Members of the Company are designated by "S," Commissioners by a "C," followed by the dates of their election or the year in which their names appear in the records.¹ Charters, indentures, etc. have been indexed under the heading "Documents." Further, it was impossible to identify recipients of letters on p. 28, 80-82, and 265-66.
