

### Introduction

The Carter Family Papers, 1659–1797, includes land documents, correspondence, and diaries of Landon Carter and of his son Robert Wormeley Carter in the Sabine Hall Collection. The principal figure in this collection is Landon Carter, son of Robert ("King") Carter, and successful Virginia planter and politician.

The Sabine Hall Collection on deposit from the Reverend T. Dabney Wellford at the University of Virginia Library has accumulated at Sabine Hall since its construction in the 1740's and has been preserved by Landon Carter and his direct descendants. The collection housed at the University of Virginia Library is incomplete; three sales have diminished it. In 1889 C. F. Lee, Jr. bought from Robert Carter Wellford a group of letters to Landon Carter from George Washington, Peyton Randolph, Richard Henry Lee, Francis Lightfoot Lee, and others. In 1892 R. C. Wellford sold to William F. Havemeyer approximately fifty letters addressed to Landon Carter from such notables as Carter Braxton, Francis Lightfoot Lee, John Randolph, Governor Francis Fauquier, Richard Henry Lee, Nelson Berkeley, and George Washington. Unfortunately, the location of Havemeyer's collection is unknown at present. The final sale took place in 1935 when the College of William and Mary bought from A. N. Wellford about 4,500 papers of the period 1820–1860, one hundred late eighteenth-century letters, and several account and memorandum books. The rest of the Sabine Hall Collection was deposited in the University of Virginia Library in three groups. Mrs. A. N. Wellford delivered some of the Landon Carter diaries in 1943. The following year the bulk of the collection (more diaries and about 600 manuscripts covering the period 1659–1871) was deposited by Mrs. Wellford. Two copper plates were lent in 1946, and the following year the last of the diaries was deposited.

### Bibliographical Note

Relatively few manuscript collections contain material directly related to the Sabine Hall Collection. Correspondence of Landon Carter at the Virginia Historical Society and the College of William and Mary has been copied and included in this microfilm edition. Landon Carter's diary and daybook for 1766–1767 and Robert Wormeley Carter's diaries of 1764 and 1765 are available at the William L. Clements Library of the University of Michigan. Robert Wormeley Carter's diary of 1774 is in the archives of the American Antiquarian Society, and the College of William and Mary has a large collection (8,226 items) of Robert Wormeley Carter's papers and diaries.

The principal collections of the papers of Robert ("King") Carter, 1663–1732, which contain many references to his sons, may be found at Duke University, the Virginia Historical Society, the Library of Congress, and the University of Virginia Library. Also of interest are two theses about Robert ("King") Carter and his family: Carl F. Cannon, Jr.'s "Robert ('King') Carter 'of Corotoman'" (Duke University, 1956, 291 pages) and Edmund Berkeley, Jr.'s "Robert 'King' Carter" (University of Virginia, 1961, 175 pages).

Excerpts from Landon Carter's diaries are printed in the William and Mary Quarterly, First Series, XIII-XXI (1904-1913), passim, but the transcriptions are incomplete and often inaccurate. Jack P. Greene's edition of The Diary of Colonel Landon Carter of Sabine Hall, 1752-1778 (Charlottesville, 1965) is not only a complete and accurate copy of all the extant diaries, but also contains a fine introduction and extensive footnotes. Walter Ray Wineman's The Landon Carter Papers in the University of Virginia Library: A Calendar and Biographical Sketch (Charlottesville, 1962) was compiled from the correspondence in the Sabine Hall Collection but contains no entries for the diaries in this collection.

Other works related to this collection include The Carter Family Tree (Richmond, 1897) by Randolph Carter and Oliver Carter Marion, and Thomas Allen Glenn's Some Colonial Mansions and Those Who Lived in Them (Philadelphia, 1899). Louis B. Wright's The First Gentlemen of Virginia (San Marino, California, 1940) reveals much about the cultural milieu of colonial Virginians, especially the Carters. Louis Morton's Robert Carter of Nomini Hall (Williamsburg, 1941) and his article, "Robert Wormeley Carter of Sabine Hall: Notes on the Life of a Virginia Planter," in the Journal of Southern History, XII (1946), pages 345-365, contain pertinent information on the Carter family, as does Jackson T. Main's "The One Hundred," in the William and Mary Quarterly, Third Series, XI (1954), pages 354-384. Edmund S. Morgan's Virginians at Home: Family Life in the Eighteenth Century (Williamsburg, 1952) and Jane Carson's Colonial Virginians at Play (Williamsburg, 1965) cite Landon Carter's letters and diaries to illustrate the characteristics of life in colonial Virginia.


### Editorial Procedure


The Carter Family Papers, 1659–1797, consisting of private letters, land documents, and diaries of Landon and Robert Wormeley Carter, are divided into two series and arranged chronologically according to physical type; correspondence and land documents followed by bound diaries. Correspondence in the Sabine Hall Collection has been supplemented with copies of Landon Carter's correspondence from other institutions. Such additions are identified by a tag which precedes the document and indicates its date, originator and recipient, and the repository of the item.

All diaries included in this microfilm publication are part of the Sabine Hall Collection at the University of Virginia Library. The diaries (Rolls Two through Four) have been filmed at a reduction ratio of eight to one, and, for the most part, appear as a single page per frame. When the physical condition of an item has prevented single-page placement, two pages appear on a single frame of microfilm. The correspondence has been filmed at a reduction ratio of fourteen to one except for certain large land documents filmed at sixteen or eighteen to one. Frame numbers, beginning anew on each roll, have been included to facilitate location and citation of items and to provide a basis for indexing.

The dates on some documents before 1752 are expressed in Old Style (the Julian Calendar) since it was not until September 2, by act of George II, that England and all British Colonies shifted to New Style (the Gregorian Calendar). Thus, the day after September 2, 1752, became September 14, 1752. A further complication of the Old Style dating is that March 25 was considered the first day of the New Year—January, February, and most of March bearing the date of the preceding year. Dates of this nature are expressed as follows: 1750/51 March 23, or essentially in Old Style with the 51 referring to New Style. Such documents appear in the order in which they were created.

Walter Ray Wineman's The Landon Carter Papers in the University of Virginia Library: A Calendar and Biographical Sketch, based on the Sabine Hall Collection, serves only as a partial finding aid since it contains entries for approximately two-thirds of the correspondence included in this microfilm publication. Additional finding aids include a List of Correspondents, consisting of brief identification of those represented in the collection and the dates of their letters, and Roll Notes, a brief description of the arrangement and contents of each roll.

### Roll Notes

Roll One: Land Documents and Correspondence 1650 May 22, 1659 November 2–1774 December 5

Roll One begins with a series of land documents, both maps and indentures, showing the evolution of the Sabine Hall estate. Included in the correspondence are commercial letters pertaining to the tobacco and slave trade, and Landon Carter's letters to the printers of the Virginia Gazette about his political essays. Letters and documents prepared by Thomas Bryan Martin concerning Landon Carter's disputed quit-rent accounts also appear here. Personal correspondence includes that with his neighbor, John Tayloe II; the Reverend Isaac William Giberne, rector of Lunenburg Parish; Ralph Wormeley, Jr.; and Dr. Walter Jones. Family relations, agriculture, and politics are discussed in Landon Carter's correspondence with his brothers Charles Carter of Cleve and John Carter of Corotoman and Shirley, his nephew Charles Carter of Corotoman and Shirley, and his son Robert Wormeley Carter. The political letters of Richard Henry Lee fall entirely in this roll.

Roll Two includes the remaining correspondence of Landon and Robert Wormeley Carter in the Sabine Hall Collection. Fur-

ther letters of the Reverend Isaac W. Giberne and Dr. Walter Jones appear here, and various members of the Carter family are also represented. However, the bulk of the correspondence is of a political nature, with major emphasis on the Revolution, and includes Landon Carter's continued correspondence with the printers of the *Virginia Gazette* about his political essays, and single letters of such figures as Philip Key, Josiah Parker, and Edmund Pendleton.

Following the correspondence are the diaries of Landon Carter. First in this series is his daily record of the transactions in the House of Burgesses. In contrast to the predominantly political character of the House of Burgesses diary, the other diaries in the Sabine Hall Collection contain a variety of observations on medical, agricultural, political, and personal topics. The later diaries also reveal the increasingly choleric and eccentric sides of Landon Carter's nature. Because the general characteristics of all the remaining diaries are similar, they have simply been listed by date for Rolls Three and Four below.

- WOODBRIDGE, JOHN (1706-1769): Burgess from Richmond County, 1742-1749, 1752-1769; member, Committee of Propositions and Grievances, 1752-1769; presiding justice of the peace, Richmond County Court, 1767 —— 1765 July 5.
- WORMELEY, JOHN (died 1785): Of Lancaster County; planter —— 1773 August 23.
- WORMELEY, RALPH (ca. 1715-1790): Of Rosegill; burgess from Middlesex County, 1742-1764; brother of Elizabeth Wormeley, L. C.'s first wife —— 1764 March 9; 1773 September 18.
