Introduction

On 1 October 1941, J. Edgar Hoover, who had been director of the Federal Bureau of Investigation since 1924, established a series of personal files separate from the central files of the bureau; this system included 1) a Personal and Confidential File, which was destroyed at the time of Hoover's death by Helen Gandy and Associate Director Clyde Tolson, a long-time friend; 2) about one and one-half drawers of bureau files, which were reintegrated into the central files; and 3) the Official and Confidential File, which is reproduced herein.

Hoover claimed that he kept this file in his personal custody "so that the great mass of file clerks don't get access" and "even Supervisors in the Divisions don't get access to them unless it [sic] is a case they personally are handling." Others believe that the file was used to blackmail, or at least intimidate, its subjects who were often prominent people either in or out of government; among others, Hoover maintained folders on John and Robert Kennedy, Lyndon Johnson, and Martin Luther King, Jr. It is important to note that there is no hard evidence that Hoover ever used any of the information in this file for improper purposes, but it also should be noted that President Johnson, when asked why he did not remove the director who was past the mandatory retirement age at the time, responded that he, Johnson, "would rather have Hoover inside the tent pissing out than outside the tent pissing in."

The 164 folders fall into various and rather arbitrary categories, the most important of which are administrative, investigative, prominent persons, and information, and reflect Hoover's interests, which centered totally on the FBI. A consummate bureaucrat and empire builder, he attended to every detail of bureau operations from overseeing relations with the Secret Service on matters of presidential security to morale problems in the various field offices to the transfer of a female employee he noticed wearing a wig in the headquarters building. His folders on investigative matters and on prominent persons tended to include information that could be considered scandalous, such as the claim made in the course of technical surveillance of Meyer Lansky that Robert Kennedy was having an affair with a woman in El Paso or that others, such as Sumner Welles, were homosexuals. This kind of personally compromising gossip was frequently passed to the subjects for their information.

The file also sheds some light on Hoover's interest in promoting the FBI before the public. He took a personal interest in what was written about the bureau, both pro and con, and paid close attention to publicity such as the movie *The FBI Story* and the television series "The FBI." Moreover, the file shows an almost paranoid streak in Hoover about his own reputation; people making allegations that the director, who never married, was himself a homosexual were investigated by FBI agents, whose reports were kept in the Official and Confidential File. Finally, the file provides some insight into those activities of the bureau that raise the most troubling constitutional issues: the use of wiretaps and burglaries, the so-called black-bag jobs, and the surveillance and attempted discrediting of the civil rights movement. As well as others that have been made public under provisions of the Freedom of Information Act, the file reveals the ways in which Hoover and his colleagues used the shibboleth of national security to expand their power beyond their statutory mandate; it also reveals the complicity of several administrations, both Democratic and Republican, in this corruption of institutional purpose.

Many of the folders have been edited heavily to protect the identities both of FBI agents and informants who frequently engaged in dubious, if not illegal, activities as well as those who were the subjects of investigation but were never charged with criminal misconduct. Some folders have been deleted entirely. Given the nature of much of the information—and misinformation—contained in the file, these deletions serve to protect legitimate rights of privacy and reputation.

In preparing the material for publication, we have reproduced the folders in the order and condition in which they were provided by the Federal Bureau of Investigation. For the convenience of the researcher, however, we have inserted the abstract sheet of the individual folder immediately before the folder itself. These sheets, prepared in February 1975, provide such information as the dates of the first and last documents in the folder, the approximate length, whether or not derogatory information is contained, the category or categories in which the material falls, and an abstract of the contents. This abstract, along with the folder number and caption, also is reproduced on the Roll Contents.

Despite the limitations inherent in this file and because of the destruction of Hoover's Personal and Confidential File, we believe that this material offers particularly valuable insights into J. Edgar Hoover's administration of the FBI, the personality of the director, and the tenor of the times.
