Introduction

The United Methodist Church, from the founding of its antecedent bodies to the present, has displayed a keen interest in social justice and in assisting its members to discover the will of God in all their varied personal, community and world relationships. To this end, the General Conference has adopted a series of Social Principles including a Social Creed which is a part of the Book of Discipline. As the climate of the social milieu changes, the General Conference every four years revises and updates these statements that define one's relationship to the natural world, the nurturing community, the social community, the economic community, the political community, and the world community.

The General Board of Church and Society is the agency of the denomination charged with the responsibility of implementing the statement of Social Principles and other policy statements of the General Conference on Christian Social Concern. Its program of research, education, and action on the wide range of issues confronting the Church is formulated by three divisions: Division of General Welfare, Division of Human Relations, and Division of World Peace, as well as its Office of Constituency Services and Office of Emerging Social Issues.

In the main, the General Board of Church and Society as constituted in 1976 includes the following predecessor boards: The Board of Christian Social Concerns of The United Methodist Church, the Department of Christian Social Action of The Evangelical United Brethren Church, the Board of Christian Social Concerns of The Methodist Church, the Division of General Welfare of the Board of Church and Society of The United Methodist Church, the Division of General Welfare of the Board of Christian Social Concerns of The United Methodist Church, the Board of Temperance, Prohibition, and Public Morals of the Methodist Episcopal Church, the Board of World Peace of The Methodist Church, the Commission on World Peace of The Methodist Church, the Commission on World Peace of the Methodist Episcopal Church, and the Board of Social and Economic Relations of The Methodist Church.

The Commission on Archives and History is charged with the responsibility of preserving copies of all the publications of general church agencies. The extant record copy of the publications of the General Board of Church and Society are on file in the office of the Director of the Service Department. This microfilm series documents the agency's publications from the 1920s to 1976 and includes leaflets, pamphlets, periodical reprints and books published either by the agency or by another United Methodist agency, and other sources which were offered for sale or free distribution to the local churches. Bibliographic information is given for documents with copyright. In some instances the condition of the copyrighted document made it mandatory to film in order to preserve the information in the publication file. This series contains no publications of the Department of Christian Social Action of the Evangelical United Brethren Church nor any bodies merged to form this previous denominational unit.
