BRITAIN AND EUROPE DURING 1997

This is the bibliographical guide to the twenty fifth annual update to the PSS (Primary Social Sources) collection, *Britain and Europe Since 1945* which contains 26,000 pages of literature issued by 67 groups and organisations between 1945-1972. The 1997 update includes the documents relating to European integration issued in 1997 from the? single and multi-interest groups and organisations contributing to this collection. A number of items of an earlier date, not previously included may be found in this update.

Attention should be drawn to the nature of some of the original material reproduced. Pamphlet and leaflet material was usually produced with an eye to economy, and many are printed on poor paper. These original characteristics present difficulties of image and contrast which stringent tests and camera alterations cannot entirely overcome. These limitations also exist with privately duplicated materials from which a successful image is not always possible.

Every effort has been made to minimise these difficulties and we have tried to live with the problems in the interests of having as comprehensive a collection as possible. We have sought to exercise responsible care and to meet the standards established by the Association for Information and Image Management (AIIM) and the American National Standards Institute (ANSI).

The Action Centre for Europe Ltd (ACE) was founded in 1995. Its main activity is to commission and publish original papers by independent academic and other experts on key topics relating to the European Union, with a view to stimulating public discussion. ACE is a company limited by guarantee. It is independent of any political party or group, and is financed by the sale of publications and by voluntary donations from individuals, companies and organisations.

The Bank of England contiues to see their main role as helping to prepare the UK financial and business community for the euro by disseminating information, communicating widely about relevant issues and progress in addressing them; identifying where coordinated activity is needed, particularly in developing the infrastructure of the financial economy to embrace the euro; helping to ensure that the necessary work is agreed and undertaken; acting as a catalyst to stimulate private sector activity where necessary; putting groups facing similar or inter-related problems in touch with each other.

The majority of the people of the United Kingdom want effective involvement in the European Community and are against a federal and unitary Europe.

The Great College Street Group was formed in October 1992 in order to oppose the Maastricht Treaty. The group, consisting of academics, businessmen, lawyers and economists provided comprehensive briefs in the campaign to win the arguments in Parliament and in the country. So successful was the campaign that the Government had to resort to a confidence motion to get its legislation through. Days later, on 1st August 1993, what remained of the ERM, the centrepiece of economic and monetary union, itself the heart of the Maastricht Treaty, collapsed.

The creation of the European Foundation ("the Foundation") ensures that this work can go forward. The task now is to mount a vigorous and constructive campaign in the United Kingdom and throughout Europe for the reform of the EC as a community of independent sovereign states.

The European Parliamentary Labour Party is made up of British Labour Party members of the European Parliament. The Labour Euro MPs are Labour's voice in Europe and work alongside the British government.
